OTHER TERMS THAT MAY APPLY TO YOU

If you join our team, whether as an intern, pre-trainee, trainee, solicitor, associate, partner, consultant or as a technical, administrative, operational or other employee of the firm, additional terms and policies will apply and be notified to you. Our Letter of Engagement and Terms of Business also governs our relationship with clients and the provision of our Services in relation to any particular legal matter.

ABOUT THE INFORMATION WE COLLECT

We will collect and process the following data about you for the following purposes:

Information you give us.

Your Data. This is information about you that you give us by filling in forms on our Site or by corresponding with us by telephone, e-mail, post or otherwise in relation to the Services or any particular or ancillary matter. This includes information you provide when you use our Site, or report a problem with our Site, or when you use the Services.

The information you give us may include:

- **AML Data:** your Identity Data, passport details including passport number, nationality, photograph, proof of address, and other know-your-customer information.
- **Applicant Data:** your Identity Data and any other personal data related to you that is contained in any application made by you for any internship, traineeship or any other programme, position or role with us.
- **Identity Data:** your full name, address, e-mail address, telephone number, address, age, title and personal description.
- **Financial Data:** your financial personal data, including your bank account details, billing contact email address, PRSI number (or equivalent), tax type and status, and VAT number.
- **COVID-19 Response Related Data:** your Identity Data and any other personal data related to you contained in any contact tracing log, questionnaire, survey or form or otherwise provided in the context of our COVID-19 risk mitigation measures, business continuity planning and track and tracing obligations, including data concerning your health and location data.

Information we collect about you.

Automatically Collected Information. With regard to each of your visits to our Site we will automatically collect the following information:

- **Technical Data:** technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform, how often you use the application and other performance data; and
- **Usage Data:** information about your visit, including the full Uniform Resource Locators (URL), clickstream to, through and from our site (including date and time), products you viewed or searched for, page response times, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), methods used to browse away from the page, and any phone number used to call us.



We collect this personal data by using cookies and other similar technologies. We may also receive Technical Data and Usage Data about you if you visit other websites employing our cookies. Please see our [Cookie Policy](#) for further details.



Special categories of personal data.

We do not require or collect any personal data that is your sensitive personal data or any special category of personal data under the GDPR, unless you decide to provide this information to us and/or this information is required in the context of our COVID-19 business continuity planning and the Measures described below.

COVID-19

As an employer, we are bound to work within the framework of [Ireland's Return to Work Safely Protocol](#) (the "Protocol"), which is designed to support employers and workers to put measures in place that will help prevent the spread of COVID-19 in the workplace. Our COVID-19 office readiness and containment measures ("Measures") are dictated by the Protocol and while it is impossible to eliminate the possibility of a case in our offices, we are committed to taking all reasonably practicable steps to mitigate this risk.

To help us ensure a safe place of work and comply with government guidelines and public health advice to prevent the spread of the COVID-19, all workers and visitors to our offices, including clients or prospective clients, will, as part of the above Measures, be asked to inform us in advance of attending our offices if they have visited an affected area and/or are experiencing COVID-19 symptoms. This will include COVID-19 Response Related Data. We will only ask you to share information that is necessary and proportionate to comply with our obligations in this regard.

Additional safeguards have been put in place to ensure this information is treated in strict confidence, to restrict access to this information to designated members of our COVID-19 Response Team for these specific purposes and to ensure this information is promptly deleted or destroyed when no longer needed.

Where we are on record as the solicitors for any party to an application or proceeding before the Court, we are also required for COVID-19 track and tracing purposes to obtain contact details from all persons attending Court on behalf of the party we represent and to seek their consent to the retention and delivery up of that information to the Health Service Executive of Ireland ("HSE") if so requested. We are required to keep this information available for a period of four weeks following the said application or proceeding and will thereafter ensure its safe disposal in accordance with applicable data protection regulations.

COOKIES

What are cookies and why we use them?

"Cookies" are small text files which are stored by your browser on your computer and are normally used to gather statistical information and to analyse trends of use or access to a website.

Cookies may be placed on your computer or internet-enabled device whenever you visit us online. This allows the site to remember your computer or device and serves a number of purposes. For example, cookies may be used to save your personal preferences so you do not have to re-enter them each time you access the Site.

You can set your browser to refuse all or some browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of this Site may become inaccessible or may not function properly. WHAT WE DO WITH YOUR INFORMATION

We will only use your personal information when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract we are about to enter into or have entered into with



you.

- Where it is necessary for our legitimate interest (or those of a third party) and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal or regulatory obligation.

We have set out in the table below a description of the way we plan to use your personal data and the legal basis we rely on to do this. Where you see legitimate interests mentioned in the table below, we have included additional information about the legitimate interests pursued.

Change of purpose

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If you wish to get an explanation as to how the processing for the new purpose is compatible with the original purpose, please contact us at info@fod.ie. If we need to use your personal data for an unrelated purpose, we will notify you and we will explain the legal basis which allows us to do so. Please note that we may process your personal data without your knowledge or consent, in compliance with this Policy, where this is required or permitted by law.

How long we keep your information

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements. This means that the period of time for which we store your personal data may depend on the type of data we hold. To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements. DISCLOSURE OF YOUR INFORMATION

We do not sell your personal information to third parties for marketing purposes.

We may disclose information to third parties if you consent to us doing so as well as in the following circumstances:

You agree that we have the right to share your personal information with the following recipients or categories of recipients:

- Any department or authorised person within our firm or any member firm within our group.
- Selected third parties including:
 - barristers, legal counsel, consultants, expert witnesses, advisors, transcription and technology service providers, including IT service and support services and data room providers;
 - business partners, suppliers and other sub-contractors for the performance of any contract we enter into with them or you in relation to the Services;
 - third parties involved in hosting or organising events, seminars or webinars with or for us;
 - third parties we engage to provide marketing automation platform services and email marketing services (where we have a valid legal basis to send such marketing communications to you);
 - our professional and legal advisors;
 - our financial and legal auditors (including auditors of the Law Society of Ireland) and any other regulatory or government agency, authority (including any tax authority, the HSE or any other public health authority) or department whose rules, regulations or orders apply to the conduct of our business and/or the provision of the Services;
 - analytics and search engine providers that assist us in the improvement and optimisation of our Site;
 - credit reference agencies for the purpose of assessing your credit score to the extent this is a condition of us entering into a contract with you.

We will disclose your personal information to third party recipients:

- in the event that we sell or buy any business or assets, in which case we will disclose your personal data to the prospective seller or buyer of our business or assets.
- if all or substantially all of our business or assets are acquired by or transferred to a third party whether in the event of a merger, reorganisation, transfer of undertakings, winding up or dissolution or any other similar circumstances, in which case personal data held by it about our clients will be one of the transferred assets.
- if we are under a duty to disclose or share your personal data with any regulatory or other official authority or in order to comply with any law, legal obligation or court order, or in order to enforce rights under the GDPR or other agreements.
- to protect our rights, property or safety, our customers, or others. This includes exchanging information with other companies and organisations for the maintenance and security of the Site and Services.

INTERNATIONAL TRANSFERS

Our servers are located in Ireland.

Personal data may be transferred to our trusted partners and service providers who maintain their servers outside of the European Economic Area (“EEA”), where the privacy and data protection laws may not be as protective as those in your jurisdiction. This is only for the purposes of providing, and to the extent necessary to provide, the Services to you.

We appreciate that there are special requirements set out under Chapter V of the GDPR (with which we would comply) to regulate such data transfers and ensure that adequate security measures are in place to safeguard and maintain the integrity of your personal data on transfer.

SECURITY MEASURES

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

YOUR PERSONAL DATA AND YOUR RIGHTS

Accessing your Personal Data.

You may request access at any time to a copy of the personal data we hold about you. Any such request should be submitted to us in writing and sent to info@fod.ie. We may need to verify your identity in such circumstances and may request more information or clarifications from you if needed to help us locate and provide you with the personal data requested.

There is usually no charge applied to access your personal data (or to exercise any of the other rights). However, if your request is clearly unfounded, repetitive or excessive, we may charge a reasonable fee. Alternatively, we may refuse to comply with your request in these circumstances.

Right of Restriction.

You may restrict us from processing your personal data in any of the following circumstances:

- you have contested the accuracy of the personal data we hold on record in relation to you or for a period of time to enable us to verify the accuracy of the personal data;
- the processing of your personal data is unlawful and you request the restriction of use of the personal data instead of its erasure;
- we no longer require your personal data for the purpose of processing but you require this data for the establishment, exercise or defence of legal claims; or
- where you have contested the processing (under Article 21(1) of the GDPR) pending the verification of our legitimate grounds.

Corrections or Erasure (Right to Rectification and Right to Be Forgotten).

If we hold personal data concerning you which are no longer necessary for the purposes for which they were collected or if you withdraw consent for us to process your personal data, you can request the deletion of this personal data. This right, however, will not apply where we are required to process personal data in order to comply with a legal obligation or where the processing of this information is carried out for reasons of public interest in the area of public health. If the personal information we hold about you is inaccurate, you may request to have your personal information updated and corrected. To do so at any time, please contact us at info@fod.ie

Your Right to Object.

You have the right to object to the processing of your personal data at any time:

- for direct marketing purposes
- for profiling to the extent it relates to direct marketing
- where we process your personal data for the purposes of legitimate interests pursued by us, except where we can demonstrate compelling legitimate grounds for this processing which would override your interests, rights and freedoms or in connection with the enforcement or defence of a legal claim.

Should this occur, we will no longer process your personal data for these purposes unless doing so is justified by a compelling legitimate ground as described above. For more information about our marketing practices, please see the Marketing Communications section below.

Data Portability.

Where we process your personal data by automated means (i.e., not on paper) and this processing is based on your consent or required for the performance of a contract between us, you have the right to request from us a copy of your personal data in a structured, commonly used machine-readable format and, where technically feasible, to request that we transmit your personal data in this format to another controller.

Profiling.

Profiling is an automated form of processing of personal data often used to analyse or predict personal aspects about an individual person. This could relate to a person's performance at work, economic situation, health, personal preferences, reliability, behaviour, location or movements. An example of this would be where a bank uses an automated credit scoring system to assess and reject a loan application.

We, however, do not engage in profiling or automated processing for profiling purposes.

Personal Rights

The rights described in this section are personal rights and are exercisable only by the individual person (or data subject) concerned.

MARKETING COMMUNICATIONS

General.

We will not use your data to send marketing communications to you about promotions, competitions, updates and new products or services that may be of interest to you, unless we have your permission to do so.

Your right to object.

You have the right to object to the processing of your personal data for our marketing purposes. To object or if you change your mind at any later time, you can withdraw your consent to the processing of your personal data for such marketing purposes by contacting us at info@fod.ie. You may also opt out of receiving marketing communications at any time by selecting the unsubscribe option when you receive an electronic marketing communication from us. The withdrawal of your consent will not impact upon the lawfulness of processing based on your consent prior to the withdrawal.

Networking and events.

If you follow or connect with us on any social media platform and/or register to attend, and attend, any event, seminar or webinar we host, manage or participate in, you understand we will process certain personal data relating to you for these purposes and to communicate with or respond to you in this way. You will be free at any time to opt out of receiving updates or information from us about our future events or seminars by contacting us at info@fod.ie or by selecting the unsubscribe option. Your account with and use of any third party social media platforms will be subject to their respective terms and conditions.

THIRD PARTY MATERIAL

We always endeavour to deal with vendors and other third parties who are GDPR compliant or, in the case of the third parties located outside of the EEA who have adequate security measures in place to safeguard the security of personal data. That said, we, our employees, agents, holding company and subsidiaries, accept no liability howsoever arising for the content or reliability of any third party materials or websites referenced by hyperlink or other means on the Site or for the data collection and use practices or security measures used by such third parties. If you submit personal data to any of those sites, your personal data is governed by their privacy policy. We encourage you to carefully read their privacy policies.

CHANGES TO THIS POLICY

Any changes made to this Policy from time to time will be published at the Site.

Any material or other change to the data processing operations described in this Policy which is relevant to or impacts on you or your personal data, will be notified to you in advance by email. In this way, you will have an opportunity to consider the nature and impact of the change and exercise your rights under the GDPR in relation to that change (e.g., to withdraw consent or to object to the processing) as you see fit.
